RESOLUTION AUTHORIZING THE CITY MANAGER TO SIGN A SCHOOL  
RESOURCE OFFICER CONTRACT WITH THE OGDENSBURG CITY SCHOOL  
DISTRICT

WHEREAS, the Ogdensburg City School District Board of Education desires to contract with the City of Ogdensburg for the provision of a School Resource Officer by the Ogdensburg Police Department, and

WHEREAS, the City of Ogdensburg recognizes the importance of the role of a School Resource Officer, and

WHEREAS, the Ogdensburg City School District Superintendent, the Ogdensburg Police Chief and the Ogdensburg City Manager have negotiated a mutually acceptable contract for the provision of these services, effective July 1, 2019 through June 30, 2024,

NOW, THEREFORE, BE IT RESOLVED, that the Ogdensburg City Council hereby authorizes the Ogdensburg City Manager to sign a contract with the Ogdensburg City School District for the provision of a School Resource Officer as enumerated within the contract, and be it further

RESOLVED, that copies of this resolution be given to the Ogdensburg City School District Superintendent and to the Ogdensburg Police Chief.
