SWIMMING LESSONS: \$30 for 1st CHILD, \$25 FOR ADDITIONAL CHILD

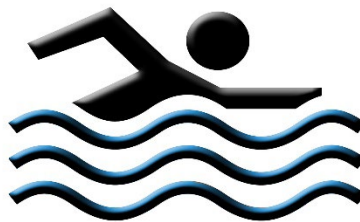
Swimming lessons will be offered for all skill levels. The instructors are fully certified and will offer the standard Red Cross Program. Each child will be placed in a half hour time slot determined on the testing days. The lessons are for children ages 4 through 14 and will be held ***Tuesday through Friday from 9-11:30 AM***. Testing and group assignments will be held July 6-7 (possibly July 8). Lessons will be held from July 12, 2022 through August 12, 2022.

EARLY BIRD ADULT SWIM:

The adult only program is held ***Tuesday and Wednesday*** from 6:30 – 7:30 AM. This program will begin July 5, 2022 and will go until August 10, 2022. Cost is \$3 a day.

POOL PARTIES:

Pool parties are now being offered through the Recreation Department from 10 AM to noon on ***Saturdays and Sundays*** beginning July 2, 2022 and ending August 14, 2022. The two- hour span would occur prior to public swimming opening at noon on the weekends. Cost will be \$50 an hour.

In consideration for being permitted to utilize the facilities, services, and programs of the City of Ogdensburg for my purpose including but not limited to observation or use of facilities or equipment or participation in any program affiliated with the City's Recreational programs, without respect to location, the undersigned, for himself or herself and any personal representatives, heirs, and next of kin, thereby acknowledges, agrees and represents that he or she has, or immediately upon entering or participating will inspect and carefully consider such premises and facilities or the affiliated program. It is further warranted that such entry into the Elsa M. Luksich Municipal Pool for observation or use of any facilities for equipment or participation in such affiliated program constitutes an acknowledgement that such premises and all facilities and equipment thereof and such affiliated programs have been inspected and carefully considered and that the undersigned finds and accepts same as being safe and reasonably suitable for the purpose of such observation, use or participation.

IN FURTHER CONSIDERATION OF BEING PERMITTED TO ENTER THE ELSA M. LUKSICH MUNICIPAL POOL FOR ANY PURPOSE INCLUDING BUT NOT LIMITED TO OBSERVATION OR USE OF FACILITIES OR EQUIPMENT, OR PARTICIPATION IN ANY PROGRAM AFFILIATED WITH THE CITY'S SUMMER RECREATIONAL CAMPS, WITHOUT RESPECT TO LOCATION, THE UNDERSIGNED HEREBY AGREES TO THE FOLLOWING:

THE UNDERSIGNED HEREBY RELEASES, WAIVES, DISCHARGES AND COVENANTS NOT TO SUE the City of Ogdensburg, its directors, officers, employees, and agents (hereinafter referred to as "releasers") from all liability to the undersigned, his personal representatives, assigns, heirs, and next of kin for any loss or damage, and any claim or demand therefore on account of injury to the person or property or resulting in death of the undersigned, whether caused by the negligence of the releaser or otherwise while the undersigned is in, upon, or about the premises or any facilities or equipment therein, or participating in the any program affiliated with the City of Ogdensburg Recreation Program, without respect to location.

Luksich Municipal Pool or participating in any program affiliated with the City's Recreation Program whether caused by the negligence of the releasers or otherwise.

THE UNDERSIGNED HEREBY ASSUMES FULL RESPONSIBILITY FOR ANY RISK OF BODILY INJURY, DEATH, OR PROPERTY DAMAGE due to negligence of releasers or otherwise while in, about, or upon the premises of the Elsa M. Luksich Municipal Pool and/or while using the premises or any facilities or equipment thereon or participating in any program affiliated with the City's Recreation Program.

THE UNDERSIGNED further expressly agrees that the forgoing RELEASE, WAIVER AND INDEMNITY AGREEMENT is intended to be as broad and inclusive as is permitted by the law of the State of New York and that is any portion thereof is held invalid, it is agreed that the balance overall notwithstanding, continue in full legal force and effect.
