Subject: Felony Drug Arrests

On the date of July 12th, 2022 Members of the Ogdensburg Police Department responded to Olympia Sports for a report of a shoplifter fleeing the area with stolen merchandise. Upon arrival members of the Ogdensburg Police Department located and apprehended the shoplifter. The subsequent investigation revealed that the shoplifter was also in possession of approximately 2.5 grams of Methamphetamine.

Steven E. Davis was arrested and charged with Petit Larceny in violation of section 155.25 of the NYS Penal Law (A Misdemeanor) and Criminal Possession of a Controlled Substance in the 4th Degree in violation of 220.09 subdivision 4 of the NYS Penal Law (C Felony). Davis was arraigned by the Honorable Marcia Lemay and remanded to the St. Lawrence County Correctional facility without bail. The Ogdensburg Police Department was assisted in the investigation by New York State Parole.

Also on July 12th 2022 Members of the Ogdensburg Police Department Criminal Investigation Unit conducted an investigation culminating with the execution of a search warrant at 500 New York Avenue Apartment 2 in the City of Ogdensburg. The execution of the warrant did result in the seizure of substantial quantities of Crack Cocaine and Fentanyl packaged for sale, as well as a sum of money. The investigation resulted in the arrest of Nicole M. Regan for 2 Counts of Criminal Possession of a Controlled Substance in the 3rd degree in violation of NYS Penal Law section 220.16 subdivision 1 (B Felonies). Regan was arraigned by the Honorable Keith Massey and remanded to the St. Lawrence County Correctional Facility without bail.

The Ogdensburg Police Department was assisted in the investigation by US Homeland Security Investigations, US Border Patrol, New York State Police, and the St. Lawrence County Sheriff's Office.
