Subject: Sex abuse on child investigation

On the date of July 24th, 2022 members of the Ogdensburg Police Investigation unit opened an investigation into a complaint of sexual contact with a minor over several years. At the conclusion of the investigation one William J. Laflair -DOB(01/09/68) of 131 Proctor Ave., Ogdensburg, NY was arrested for Sex Abuse in the first degree section 130.65 sub 3 of the penal law of the state of New York. William was released to the supervision of probation.
